complications and chemotherapy consent was taken. After ensuring adequate organ reserve chemotherapy was given.

CHEMOTHERAPY - PROTOCOL:

- · Cap. Aprecap 125mg PO stat
- Inj. Palinox 0.25mg + Inj. Dexa 8mg in 100ml NS IV over 10 minutes
- Inj. Avil 1amp + Inj. Hydrocort 100mg in 100ml NS IV over 10 minutes
- Syp Benadryl 10ml oral stat
- Inj. Phenergan 12.5mg deep IM stat
- Tab. Dolo 650mg Oral Stat
- Inj. Taxonab 1**8**0mg IV in 300ml NS over 1 hour
- Inj. Carboplatin 300mg IV in 300ml NS over 1 Hour.

Patient tolerated chemotherapy well and is discharged in hemodynamically stable condition with following advise.
