Socio-Demographic Details:

Little Master Mr Shreyan is a 2 years 8 months old male child, Hindu, hailing from a middle socio-economic status and coming from an rural background. He was brought by his Parents, with the following

Chief Complaints:

- Age-inappropriate speech
- Self-laugh
- No response for name call
- Does not stay at one place
- Easily Frustrated
- Sleeps late
- Not able mingle with others

Duration: 3 months

Brief Clinical History:

According to the parent's (Father) report, the child is not having age-appropriate speech. And does not respond to when called by his name and often laughs by himself. The father stated that the child does not sit at one place and roams about the room repeatedly and when the needs of the child is not fulfilled, he gets easily frustrated and bangs his head towards wall. The informant also added that the child always seeks perfectionism and always clings with the parents and does not wish to mingle with others. The father also reported that the child is facing difficulties with the sleep at night.

The father stated that the child was taken to a local doctor for a regular checkup and was suggested for intervention about child having features of autism.

With the above chief complaints, the parents brought the child to Sweekaar on 13/06/2024.

Birth and Developmental History:

The Child was born to non-consanguineous parents. It was full-term caesarean birth (reason for caesarean is due to excessive amniotic fluid). Immediate Birth cry was present and birth weight was 3 kgs. All the developmental mile stones were delayed for 1 month and not achieved age appropriately.

Behavioural Observations:

The child was well-kempt, Eye contact was partially maintained, rapport could not be established with ease as the child was clinging to the parent continuously during examination. Attention and concentration were not aroused and sustained. The child was irritable throughout the session.

Tests Administered

- 1) Denver Developmental Screening Test (DDST)
- 2) Vineland Social Maturity Scale (VSMS)
- 3) Childhood Autism rating Scale (CARS)

Test Findings:

1. Developmental Screening Test (DDST):

It was administered to assess the developmental functioning of the child. On DST the Obtained **Developmental Age (DA)** was **1 year 11 months** and the corresponding **Developmental Quotient (DQ)** was **72**, indicating **Borderline deficits in Developmental functioning.**

2. **Vineland Social Maturity Scale (VSMS):**

It was administered to assess the socio-adaptive functioning of the child. The obtained **Social Age (SA)** was **2 years 1 months** and the corresponding **Social Quotient (SQ)** was **78**, indicating *Borderline deficits in socio-adaptive functioning*.

3. **Childhood Autism Rating Scale (CARS):**

This test was administered to assess the features of autism of the child. The obtained score was **31** Indicating *Mild Autistic Features*

Impression:

Based on the Chief complaints, Birth and Developmental history, Clinical history, Behavioural and clinical observations and psycho diagnostic evaluation suggest that the child is provisionally diagnosed as **“Mild Level of Autistic features with Borderline deficits in developmental and socio-adaptive functioning”**.

Suggestions and Recommendations:

- 1) Psychoeducation and parental guidance
- 2) Consult Rehab Medical Specialist
- 3) Behaviour Therapy
- 4) Occupational Therapy
- 5) Speech Therapy
- 6) Reassessments after 6 months
- 7) Review after one month

Brief History: Unable to speak Age appropriately.

Birth History: Mother's age of conception was 24 years. Child is 1st issue to non-consanguineous parents. Natal history reveals Full term cesarean delivery with immediate birth cry and birth weight of (3kgs). H/O Child had neonatal jaundice and was given phototherapy for 2hrs. No other complications reported by parents.

Oro-Peripheral Mechanism Examination: OPME was observed to be structurally normal and functionally adequate. Vegetative skills are adequate except blowing. Pre linguistic skills adequate except for eye contact and imitation of speech. Cognitive prerequisites are adequate.

Motor Development: Age -appropriate motor development.

Speech and Language Evaluation: Child's main mode of communication is non-verbal. Child can comprehend simple verbal requests and unable to follow commands. Child can recognize parents. Child receptive vocabulary consists of few body parts, few food items and functional words. Child expressive vocabulary consists of babbling. Child expresses his needs through vocalization and dragging parents' hands towards the object. Jargon speech was observed during play.

Reception: 8-9 months.






